

# TYPE APPROVAL DECISION

Eurofins Expert Services Oy has, based on the act given about the approval of certain construction products (954/2012) 5§ and taking into account the provisions of the chapter 2 and provisions of 1§ of decree given by the Ministry of the Environment on the approval of certain construction products (555/2013), issued the following type approval.

<b>Product</b>	<b>Tectite Classic push-fit fittings for PEX-pipes:</b> Dimensions 10, 12, 15, 18, 22 and 28 mm. Straight-, elbow- and T-fittings.
<b>Scope of the approval</b>	This approval certifies that the above mentioned fittings fulfil the requirements set for fittings for PEX-pipes in the national decree 499/2019
<b>Conditions of the approval</b>	The technical information of the product and the installation instructions shall be delivered with the product when needed. Inserts shall be used when jointing PEX-pipes.
<b>Marking</b>	The product shall be permanently marked with the manufacturer's sign, size, marking "CR" and traceability information. The markings shall be according to standard SFS-EN 15875-3. In addition, the product or the package shall be marked with the type approval mark or number <b>22-003983-TH</b> . Alternatively, the type approval marking can be printed on the document following the product.
<b>Validity period</b>	The validity of this decision starts on 12.12.2022 and ends no later than 12.12.2027.

**REMARKS**

If the product enters the CE marking, the type approval expires.

The type approval decision is issued for a fixed period, for a maximum of five years at a time.

**CANCELLATION OF THE TYPE APPROVAL**

The type approval decision will be cancelled if:

- The construction product does not fulfil the requirements presented in the land use and building act or the technical requirements based on the act.
- The importer or the manufacturer or its representative does not correct the flaws detected by the quality control.
- The usage of the construction product is prohibited by Finnish Safety and Chemicals Agency (Tukes) or the importer or the manufacturer or its representative is ordered to withdraw the product from the markets by Tukes.
